

# Saint Mary's University: Tradition and Excellence

Founded in 1802, Saint Mary's University is one of the oldest degree-granting institutions in Canada. # **Admission Requirements**

- A four-year university degree in finance or other quantitative-related discipline such as engineering, with an overall minimum average of B.
- Applicants whose first language is not English or who did not complete their entire degree from an English medium university require a minimum English proficiency score of:
  - IELTS 6.5 (6.0 for conditional admission)
  - TOEFL 550 or iBT® 80 or equivalent (72 in iBT® for conditional admission)

Students accepted conditionally must meet the terms of their acceptance before attending the MFin program. In order to meet the requirement for full admission, these students are eligible to attend our eight-week pre-MFin language course submit an improved score.

#### **Entrance Scholarships**

There are two types of entrances scholarships available for the 2018-2019 academic year. Some applicants may qualify for both.

Canadian Citizens or Permanent Resident card holders who are accepted into the MFin program are automatically considered for a \$4,000 entrance scholarship when their file is reviewed.

Applications who have successfully passed the CFA **Level 1 exam** and are accepted into the MFin program are automatically considered for a \$4,000 entrance scholarship when their file is reviewed.
